Sunset Elementary School – Notice of Probation

Dear Parent(s)/Guardian,

The International Studies Magnet Program at Sunset Elementary has a rigorous curriculum designed to provide a meaningful educational experience for each student. When eligible students and their families exercise their school choice option to enroll in the Magnet program at Sunset Elementary, they agree to maintain their grades, attendance, and behavior within established expectations. Students enrolled in the Magnet program must comply with the following requirements and expectations to remain enrolled:

Academic Performance

- Maintain a grade point average of 2.0 or higher in all Magnet courses and a 2.0 overall in all core courses each year.
- Maintain a minimum of a 2 in effort for Magnet and cores courses.

Behavior and Conduct

- Maintain a conduct grade of a "C" or higher in all Magnet and core courses each year.
- Violation of the Miami-Dade County Public Schools Code of Student Conduct may result in probation or possible immediate exit from the program.
- Excessive referrals will result in a behavioral contract, probation, and possible exit of the Magnet program.
- Students who violate Level III, IV, or V of the Code of Student Conduct will not be allowed to return to the Magnet program.

Attendance

• Maintain school attendance per School Board Policy 5200, which states that a student may not accumulate more than 10 unexcused absences in an annual course or more than 5 unexcused absences in a semester course.
